





NOTICE OF NOMINATION FOR OFFICE Municipal Election Act, 1996(s.32)

Are you Interested in running for Municipal Office or as a School Board Trustee in the 2018 Municipal Election?

NOTICE is hereby given to the Municipal Electors of:

Township of Brudenell, Lyndoch and Raglan Township of Killaloe, Hagarty and Richards Township of Madawaska Valley Township of South Algonquin

NOMINATIONS:

Nominations for the positions listed below must be made on the prescribed form which will be available at your municipal Clerk's Office. Nomination forms must be filed at your municipal office, with the prescribed declaration signed by at least 25 persons, and the persons endorsing the nomination must be eligible to vote in an election for an office within the municipality of the person filing the nomination form, if an election was held on the day that the person endorses the nomination. (This requirement may be amended by the province to exclude municipalities with less than 4000 electors). Nominations must be accompanied by the nomination filing fee of \$200 for Head of Council, or \$100 for all other offices. The filing fee may be paid by cash or debit, or by certified cheque or money order made payable to the municipality. (Check with your municipal office to see what form of payment is accepted).

Nomination Period:

May 1, 2018 – July 26, 2018 during regular office hours Nomination Day - July 27, 2018 from 9:00 am to 2:00 pm.
