**NOMINATIONS:**

Nominations for the positions listed below must be made on the prescribed form which will be available at your municipal Clerk's Office. Nomination forms must be filed at your municipal office, with the prescribed declaration signed by at least 25 persons, and the persons endorsing the nomination must be eligible to vote in an election for an office within the municipality of the person filing the nomination form, if an election was held on the day that the person endorses the nomination. (This requirement is amended by the province to exclude municipalities with less than 4000 electors). Nominations must be accompanied by the nomination filing fee of \$200 for Head of Council, or \$100 for all other offices. The filing fee may be paid by cash or debit, or by certified cheque or money order made payable to the municipality. (Check with your municipal office to see what form of payment is accepted).

**TAKE NOTICE** that nominations may be filed from **Monday May 2, 2022 to Thursday August 18, 2022** during regular office hours or on Nomination Day – **Friday, August 19, 2022 from 9:00 am to 2:00 pm.**
