Mayor Mayville acknowledged the passing of long time Township volunteer Bruce Burnett; indicating he was very active in the community, serving as a volunteer with the Heritage and Ecology Society, the Killaloe Farmers Market, the Friendship Club, the Killaloe and Area Lions Club, the Killaloe and District Public Library and the Friends of the Library. Mayor Mayville indicated that he will be missed by family, friends and the community.

Mayor Mayville inquired with Council as to whether they would like to continue to receive correspondence from him as well as the Renfrew County District Health Unit as it pertains to COVID-19. Council advised that unless the information pertains to the Township specifically they felt they did not need to receive the information.

Reports:

Public Works Superintendent:

Public Works Superintendent Dean Holly was present and invited to give his report. Public Works Superintendent Holly reported that his department continues with regular road maintenance, cold patching, grading, grass cutting along the roadways, opening culverts, and regular maintenance on equipment. Public Works Superintendent Holly advised that they will be picking up the dock sections for the Round Lake boat launch, that the dozer should be operational this week, and road projects on Stone Church Road and Hillcrest Avenue may begin earlier than expected. Public Works Superintendent Holly indicated that the sidewalk plow is being used for cutting the grass along the roadways and the rotary assembly for the knives are in bad repair. Public Works Superintendent Holly noted that he received estimates for the repair; \$13,000.00 for a partial repair and \$15,862.00 for the complete head. Council discussed and asked that the repair be accounted for in the 2024 budget. Public Works Superintendent Holly had no objection. Public Works Superintendent Holly reported that sometime in August there will be a demonstration on catch basins/sewer systems. Council asked that they be notified closer to the date so they could attend this demonstration as well.

Council thanked Public Works Superintendent Holly for his report at which time he left the meeting.

CAO/Clerk – Treasurer: CAO/Clerk – Treasurer Tammy Gorgerat was present and invited to give her report. CAO/Clerk – Treasurer Gorgerat advised that the Round Lake Property Owners Association AGM is set to take place on Saturday July 22, 2023 at 9:30 am at the Round Lake Recreation Park and was asked to clarify who from Council would be in attendance. Mayor Mayville and Councillors Lavigne, MacMillan, Kuehl, Browne and Pecoskie will be in attendance.

CAO/Clerk – Treasurer Gorgerat inquired with Council if they wanted to consider requesting "proposals" in the purchase requirements for the sale of the surplus lands on Queen Street. Council decided not to require "proposals" for the purchase of these lands.

CAO/Clerk – Treasurer Gorgerat advised that she received an inquiry from Nicole Zummach; Librarian of the Killaloe & District Public Library asking for assistance in obtaining a credit card as the Library itself can not obtain one due to a naming discrepancy. CAO/Clerk – Treasurer suggested the Library be included under the Township's credit card account and when purchases are made the Library will be invoiced. Council had no objections to this suggestion.

Council thanked CAO/Clerk – Treasurer Gorgerat for her report.

Committee Reports:

Mayor Mayville asked for each Committee Chair to provide a report.

Councillor MacMillan reported that the Economic Development Committee has sent out a number business survey's, has taken photographs of local business to feature on the Killaloe, Hagarty, Richards Naturally Spirited Facebook page, they are working on a portfolio of pictures to feature on the Township's website and the Committee is preparing to start the planning of the Loggers Sport Festival.

Councillor Smith reported that the Human Resources Committee have completed their review of the Human Resources Policies and Procedures and have made recommendations for changes. Councillor Smith advised that once the changes have been made to the policy it will be provided to Council for review.

Councillor Lavigne reported that the Public Works, Public Service and Property Committee have been working on evaluating costs of the Township's landfills and have been to two neighbouring Townships for an onsite visit to their landfills to observe how they operate their sites including costs to export and fee schedules. Councillor Lavigne advised that the Committee will bring the information to Council once it has been completed.

Councillor Kuehl noted all subjects under the Policies and Procedures Committee and indicated that once the Comprehensive Zoning By-Law has been completed then the Committee can start reviewing matters pertaining to the Policies and Procedures Committee.

Councillor Browne advised that the Protection and Emergency Management Committee had nothing to report.

Councillor Pecoskie reported that the Planning Committee has had two meetings; the first to address what the Committee was all about and the second meeting entailed having Asset Manager Dale Thompson provide an overview of the Township's asset management plan.

Councillor Smith reported that the Affordable Housing Committee had no updates at this time. Councillor Smith did advise that the Affordable Housing Alliance of Ottawa Valley Committee has submitted an application for grant funding and are waiting for a reply.
