Council for the Township of Killaloe, Hagarty and Richards met on the above date with Mayor David Mayville and Councillors Harold Lavigne, Bil Smith, Maureen MacMillan, Ted Browne, Carl Kuehl and Brian Pecoskie in attendance.

Mayor Mayville chaired the meeting which he opened and called to order.

Mayor's Address:

Mayor Mayville advised that he attended a Dr. Recruitment Zoom meeting on February 21st, a Finance and Administration Committee meeting on February 28th and a County Council meeting on February 28th noting that a discussion was had in regard to the lack of people going to the workplace and stated that an inquiry will be circulating to the Mayors and CAOs pertaining to lands available in respective townships for housing.

Pecuniary/Financial Interest:

No pecuniary/financial interest was declared by any member present.

Delegations:

Mayor Mayville welcomed County of Renfrew Manager of Human Resources Greg Belmore to the meeting. Mayor Mayville advised that having Mr. Belmore present was important for educational purposes, and that Bonnechere Valley had accomplished this in 2022, North Algona Wilberforce in 2023, Madawaska Valley just finished this year and Brudenell, Lyndoch and Raglan is discussing compensation and pay equity as of right now. Mayor Mayville advised that in his presentation, Mr. Belmore will outline the County of Renfrew's Human Resources services which includes; job descriptions, pay equity, grid reviews, the impact of COLA and performance increases and how they effect the grid.

Moved by Maureen MacMillan Seconded by Harold Lavigne

THAT Council for the Township of Killaloe, Hagarty and Richards hereby approves to extend the 15-minute time limit for delegations to 40 minutes plus 15 minutes for Council questions/comments for County of Renfrew Manager of Human Resources Mr. Greg Belmore's presentation. Carried.

Mr. Belmore thanked Council for the opportunity to present information pertaining to shared services specifically the Human Resources Department of the County of Renfrew. Mr. Belmore walked Council through his presentation highlighting shared services, human resources services, recruitment, pay equity and job evaluations, benefits administration, workplace investigations, performance management, discipline and dismissal, corporate policy creation and interpretation, labour relations, training and development, occupational health and the County's service level agreement.

Mayor Mayville inquired as to how often performance appraisals should be performed. Mr. Belmore advised that the County of Renfrew, at minimum performs them annually, however more frequently throughout the year is beneficial to the employee.

Mayor Mayville inquired what services other municipalities have acquired from the County of Renfrew's Human Resources Department. Mr. Belmore advised that the services offered are individual to each municipality, some have acquired partial services and some a complete package. Mayor Mayville inquired as to an approximate cost of services relating to job descriptions, performance reviews, and salary grids. Mr. Belmore advised that he could put together a quote pertaining to these services and provide to Council for review.

Mayor Mayville inquired what increases the "grid"; performance increases or COLA. Mr. Belmore advised that the whole "grid" overall increases with COLA.

Mayor Mayville inquired as to how much does accurate job descriptions and pay scales mean to a successful corporation. Mr. Belmore indicated that it is important as the market is very tight and competitive for employees.

Mayor Mayville inquired as to what happens when one pay scale is higher than expected, does it throw other pay scales out and should the job position be edited to portray a more appropriate score. Mr. Belmore advised that having a higher-than-expected rating can throw out other pay scales, and as it pertains to editing a job description, the points should reflect with the job description. Mr. Belmore indicated that a job description should reflect the needs of the position only and not a person; it should not be forced to do something.

Councillor Smith clarified with Mr. Belmore that with the County's five (5) year pay scale steps, only merit increases happen after the five (5) year grid has been completed. Mr. Belmore advised that yes merit increases happen after the five (5) year grid steps are completed.

Council thanked Mr. Belmore for his presentation at which time he left the meeting.

Reports:

Public Works Superintendent:

Public Works Superintendent Dean Holly was present and invited to give his report. Public Works Superintendent Holly indicated that regular road and equipment maintenance/checks continue, and his department has been cold patching grading and brushing the roadways and opening-up culverts. Public works Superintendent Holly advised that with the frost coming out of the ground some of the roadways within the municipality are guite muddy and last week with the high winds there were approximately 20 trees that were in need of cleaning-up throughout the township. Public Works Superintendent Holly advised that CAO/Clerk – Treasurer Gorgerat inquired about the parking area across for Millstream Apartments indicating that Mayor Mayville received a complaint of potholes. Public Works Superintendent Holly advised that the parking area does not belong to the township and that the Public Works Department snowplows the area only in good faith, however the township does not maintain the property. Public Works Superintendent Holly inquired with Council if they would like his department to continue plowing with no maintenance or do they want to discontinue plowing this area. Council directed that the Public Works Department continue with snowplowing with no additional maintenance provided. Public Works Superintendent Holly advised that a resolution was prepared for the hiring of Mr. Emile Organ.

As it relates to waste management, Public Works Superintendent Holly reported that the loader is in for repairs and in the meantime has created some difficulty in the clean-up of refuse around the waste site, however the attendants continue to do what they can. Public Works Superintendent Holly advised that the loader will still need further repairs as well as the cardboard compactor noting that he will bring prices to the finance committee meeting for more discussion.

Council thanked Public Works Superintendent Holly for his report at which time he left the meeting.

CAO/Clerk – Treasurer:

CAO/Clerk – Treasurer Tammy Gorgerat was present and invited to give her report. CAO/Clerk – Treasurer Gorgerat reported that both herself and By-Law Officer Tyler Mask attended a Short-Term Accommodations meeting arranged by the Township of Laurentian Valley with politicians and staff to discuss the issues and concerns with short-term rentals and a report will be provided in the future and once received will forward to Council for review. CAO/Clerk – Treasurer Gorgerat advised that MP Cheryl Gallants office has inquired if Council would consider their request to host their 2024 Constituency Clinic in Council Chambers on Tuesday July 25th from 12:00 pm – 4:00 pm. Council had no objection.

CAO/Clerk – Treasurer Gorgerat indicated that she provided Council with a recommendation from Fire Chief Bob Gareau pertaining to the hiring of Matt McMurdo for the position of Probationary Firefighter.

Council discussed, reviewed and directed CAO/Clerk – Treasurer Gorgerat to move forward with the advertising of the position.
